REFUND STRUCTURE

Refund Percentage	Conditions
100%	Withdrawal up to 15 days before commencement of the academic session (Rupees 1000 Processing fee may be deducted)
90%	Withdrawal less than 15 days before the session starts
80%	Withdrawal within 15 days after the session starts
50%	Withdrawal between 16-30 days after the session starts
No Refund	Withdrawal after 30 days of the session commencement

Additional Notes

- refunds must be processed by the institutions within 15 days of receiving the withdrawal application.
- the refund policy will be clearly displayed during the admissions process and in the prospectus.
